Dear Minister Halman:

Re: EPRA Electronic Products Stewardship Program Plan

In support of the recent changes to Schedule "A", Amendment to the Solid Waste – Resource Management Regulations made by Governor in Council under Section 102 of Chapter 1 of the Acts of 1994-95, the Environment Act, EPRA is requesting approval of an amendment to our program plan. In order to fulfill compliance, EPRA will collect the additional electronic products outlined in Section "C" – Electronic Products Included in the Electronic Product Stewardship Program.

EPRA will ensure that our present list of 78 drop-off centres are informed of the changes to our program plan and will begin collection of the additional materials on or before the following dates:

1.	Floor or carpet care appliances	June 1, 2024
2.	Garment care appliances	June 1, 2024
3.	Appliances for counter-top cooking	June 1, 2024
4.	Devices for cutting food items and opening or	June 1, 2024
	sealing containers or packaging	
5.	Devices for measuring time	June 1, 2024
6.	Personal care appliances	June 1, 2024
7.	Scales	June 1, 2024
8.	Portable air treatment appliances	June 1, 2024

EPRA will incorporate messages and information to the public on the changes to the program plan in regards to the additional electronic material on or before April 1, 2024. Additional outreach to drop-off centre locations will begin on or before April 1,



2024 to ensure there is a seamless process to accepting the new materials from the public on or before June 1, 2024. This plan will include meeting with the Nova Scotia Regional Waste Coordinators Committee and Nova Scotia Solid Waste Managers and Directors Committee to ensure they are aware of the regulation changes and can coordinate information to the public through municipal waste management programs. In addition, we will outline messages on our website, "recycleMYelectronics.ca/ns" and other media sources. EPRA will also update "Point of Sale" material for retailers/stewards, brochures and signage to reflect the changes.

We have reached out to all EPRA NS registered Stewards as well as those in PE who are supplying small appliances to ensure they are aware of the June 1, 2024 expansion as well as the 6-month required notice period to the Nova Scotia Department of Environment and Climate Change.

I am also attaching a copy of a list of stewards presently registered with EPRA Nova Scotia who also sell small appliances and are currently remitting EHFs on those devices in PEI. We fully expect that additional stewards will register prior to June 1<sup>st</sup>.

We look forward to your reply and approval of the amendment to the EPRA Program Plan to move forward in fulfilling the requirements of the new regulations. Please let me know if you have any questions and thank you for the opportunity to work with your department in providing safe and secure electronic recycling for Nova Scotians.
